She briefly went over the applications that were submitted and discussed the criteria for judging whether the applications meet the guidelines established by the Commonwealth of Massachusetts for CPC eligibility. LPRD submitted applications for Turner Park for development of a Master Plan and Greenwood Park for construction of a splash pad, game tables and patio area. The possibility of submitting an amendment to have the splash pad moved to a more suitable area was discussed. The feeling is that the existing toddler pool would better be used as a patio or sitting area for the parents rather than the splash pad. A meeting will be held at Greenwood Pool to re-evaluate the plans with the Chairperson, Director and Assistant Director.

V. New Business

- a. Cliff Zundell - Director Thomas discussed the timetable for nominating candidates for the Cliff Zundell Memorial Award. The Park Board was asked to give this some thought and be prepared to discuss this at the next meeting.
- b. 2008/2009 Budget - Work has begun on the next fiscal year's budget. The deadline for submission to the Town Manager is January 4. More information will be available at the January Meeting of the Park Board.
