The *Planning Board Regular Meeting* was called to order at 7:04 p.m. by Chair Donald Holland.

**Sign Application – People’s United Bank, 670 Bliss Rd., Case #20200121-1**

Mr. Kuszpa explained that the existing “United Bank” sign is to be replaced with a new “People’s United Bank” sign made of push-through opaque acrylic lettering and a total area of approximately 16 sq. ft.. Bruce Colton made a motion, and was seconded by Ken Taylor, to approve the sign application for People’s United Bank at 670 Bliss Rd. All in favor 4-0, motion approved.

**Sign Application – Dream Nails, 927 Shaker Rd., Case #20200121-2**

Mr. Martins explain that the sign consists of a 32 sq. ft. backlit LED-lit box sign mounted vertically on the sloped roof. The rendering was presented for illustration purposes, thus sign location is merely approximate; however, it shows the top of the sign to be higher than the roof ridge, therefore mounting location must be verified prior to installation to ensure compliance with regulations. Bruce Colton made a motion, and was seconded by Ken Taylor, to approve the sign application for Dream Nails at 927 Shaker Rd., case #20200121-2, with the condition that the top of the sign is below the peak roof line. All in favor 4-0, motion passed.

- a) Bruce Colton announced that earlier in the day MA’s Office of the Attorney General approved the zoning bylaw amendments that were adopted under Article 1 at the Special Town Meeting of August 20, 2019, which was aimed to regulate public utility facilities in the Town. There are still legal hurdles to consider as Columbia Gas is state regulated entity but Tennessee Gas Pipeline is a federally regulated entity and, therefore may preempt state or local law.
